

AFFIDAVIT-CUM-DECLARATION AND INDEMNITY BOND

do hereby solemnly affirm, declare and undertake as follows:

1. I/We have applied for scholarship, fee waiver, financial assistance, concession or other financial benefit offered by the Institute ("Scholarship") and understand that grant of such benefit is subject to fulfillment of the eligibility criteria prescribed by the Institute from time to time.

2. For the purpose of Scholarship eligibility, "Family Income" shall mean the aggregate gross annual income of the Student's Father and Mother from all sources. Where eligibility is based on a Legal Guardian, it shall mean the aggregate gross annual income of such Legal Guardian(s).
3. I/We declare that all information, declarations, Income Tax Returns, income certificates, salary records, financial statements and other documents submitted to the Institute in support of the Scholarship application are true, complete, genuine and accurate.
4. I/We specifically declare that the Income Tax Returns for Assessment Year(s) 2025-26 and all supporting financial documents submitted to the Institute are authentic, validly issued and have not been forged, fabricated, manipulated, altered, procured by misrepresentation or otherwise unlawfully obtained.
5. I/We further declare that all sources of income of the Parent(s)/Legal Guardian(s), including salary, business income, professional income, consultancy income, rental income, agricultural income, investment income, pension, foreign income and any other income whatsoever, have been fully and truthfully disclosed to the Institute and that no material financial information has been concealed, omitted or suppressed.
6. I/We acknowledge and undertake that the Parent(s)/Legal Guardian(s) whose names appear in the income documents submitted at the time of admission shall continue to form the basis for determining the Student's eligibility for scholarship throughout the Student's tenure at the Institute. The Student shall, however, be required to submit the latest income documents of the same Parent(s)/Legal Guardian(s) at the beginning of each semester to the Student Welfare Division of the respective campus for assessment of the Student's scholarship eligibility. The Institute shall not permit the substitution or replacement of such Parent(s)/Legal Guardian(s) with any other person for the purpose of determining the Student's scholarship eligibility.
7. I/We acknowledge and agree that Scholarship eligibility shall be reviewed by the Institute from time to time in accordance with the applicable Scholarship policy. I/We undertake to submit, at my/our own responsibility, the prescribed Income Tax Returns, income certificates, declarations and such other financial documents as may be required by the Institute for each academic year or at such intervals as may be prescribed by the Institute. Failure to submit the required documents within the prescribed timeline may result in withholding, discontinuance or withdrawal of the Scholarship and, if any Scholarship amount or financial benefit has already been granted on a provisional basis, the same shall be liable to be recovered by the Institute.
8. I/We acknowledge and agree that grant, continuation, renewal, enhancement, reduction, suspension or withdrawal of any Scholarship, fee waiver, financial assistance, concession or other financial benefit shall be solely at the discretion of the Institute and subject to the applicable rules, policies, eligibility criteria and conditions prescribed by the Institute from time to time. I/We further confirm that I/we have read and understood the applicable Scholarship terms and conditions and that no Scholarship or financial assistance shall be claimed as a matter of right. The Institute shall be entitled to discontinue or withdraw the Scholarship upon the Student ceasing to satisfy any prescribed eligibility condition or upon occurrence of any event under the applicable rules or policies of the Institute including, without limitation, disciplinary action, misconduct, submission of incorrect information, failure to submit prescribed documents, or failure to satisfy the applicable financial or minimum academic eligibility criteria.
9. I/We expressly authorize the Institute, at any stage before admission, during the programme, after graduation, after issuance of any academic credential, or at any subsequent time, to verify or cause verification of any declaration, Income Tax Return, certificate, financial document or supporting record submitted in connection with the Scholarship application from any authority, employer, institution, bank, financial institution or other source considered appropriate by the Institute.
10. If at any stage it is found that any declaration, Income Tax Return, certificate or supporting document is false, forged, fabricated, misleading, incomplete, manipulated, or that any material income or financial

information has been concealed or suppressed, or that the Student was otherwise not eligible for the Scholarship, the Institute shall be entitled to withdraw or cancel the Scholarship, recover the entire financial benefit granted, demand payment of the applicable fees and charges, and initiate such disciplinary, civil, criminal or other proceedings as may be permissible under applicable law and the rules, policies and regulations of the Institute. The aforesaid rights of the Institute may be exercised irrespective of whether such discrepancy, concealment, misrepresentation or ineligibility is discovered before admission, during the course of study, after graduation, or after issuance of any academic credential.

11. I/We jointly and severally agree to indemnify and keep indemnified BITS Pilani, its campuses, officers, employees and representatives against all losses, claims, liabilities, damages, costs and expenses arising out of any false declaration, forged document, concealment of income, misrepresentation or wrongful receipt of Scholarship benefits.
12. I/We agree that any amount determined by the Institute to be recoverable under this Affidavit-cum-Declaration and Indemnity Bond shall constitute a lawful debt due to the Institute and shall remain recoverable notwithstanding completion of studies, withdrawal from the programme, graduation, issuance of transcript, provisional certificate, degree certificate or cessation of association with the Institute.
13. The Student and Parent(s)/Legal Guardian(s) shall be jointly and severally liable for all obligations arising under this Affidavit-cum-Declaration and Indemnity Bond, which shall remain valid and binding until all obligations hereunder have been fully discharged.
14. This Affidavit-cum-Declaration and Indemnity Bond shall be governed by the laws of India and shall be subject to the exclusive jurisdiction of the competent courts at Jhunjhunu/Pilani, Rajasthan.
